

# **Collaboration**: local alliances

## 1. Investigation and knowledge management

#### Improve the knowledge and understanding about:

- Structure and function of Andean forest ecosystems
- Socio-ecological context of Andean forest landscapes

#### Three main strategies:

- 1. <u>Continuous monitoring systems on ecosystem dynamics</u>
- Strengthening existing Andean monitoring networks RedGloria: Impact of climate change on biodiversity Andean Forest Network: Carbon – Biodiversity monitoring
- 3. Identify knowledge gaps and implement applied research

#### Three main strategies:


- 1. Identification, consolidation and promotion of relevant strategies
- 2. Valuation of Andean forests' benefits
- 3. Development and validation of methodological packages and tools for the management of Andean forests

## 3 Advocacy, replication, and upscaling

Four main strategies:

- **1. Systematization** of lessons learned on sustainable management of Andean forests
- 2. Promote opportunities for a dialogue on generated knowledge
- **3. Strengthen capacities** and disseminate information
- **4. Foster partnership** to facilitate collaborative work
